#### **Hearing to Adopt Regulation Amendments in NAC 394**

For Possible Action – The Commission on Postsecondary Education will review and take possible action on the following NACs. This information is provided pursuant to the requirements of NRS 233B.0603:

- 1. Repeal of NAC 394.600 that includes the following:
  - a. R003-24: Repeal of NAC 394.600 Removes the burdensome approval of advertisements regulation pertaining to licensed institutions.

Testified:

Commissioner Kenny stated: This hearing is being conducted in compliance with Nevada Revised Statute Section 233B.0608 for the purpose of soliciting public comments and to take possible action via a Notice of Intent to Act upon proposed regulation amendments as stated in Agenda Items H.

This hearing is the culmination of DETR's regulatory rulemaking process for proposed regulation amendments and repeals in Nevada Administrative Code Chapter 394.

Said regulatory process began on October 4, 2023, wherein the Employment Security Council convened in a public meeting and Kelly Wuest, Administrator of the Commission on Postsecondary Education introduced to the public an overview of the proposed regulation amendments and repeals in NAC Chapter 394, which is item H on today's agenda, wherein no public comment was received nor made.

On October 30, 2023, Employment Security Council conducted a Small Business Workshop to solicit public comment on the recommended proposed regulation repeal in NAC Chapter 394, which is item H on today's agenda, wherein no public comment was received nor made.

This brings us here today at this public hearing on the Notice of Intent to Act Upon Regulations, which is the final internal step in this rulemaking process before said regulatory amendments and repeals are placed on the Nevada Legislative Commission's agenda for formal action by the Legislature. DETR anticipates that taking place in August 2024.

i. Item H proposes the repeal of NAC 394.600 removing the burdensome approval requirement of advertisements pertaining to licensed institutions. This is an unnecessary and again burdensome regulation that offers no value or benefit to the Commission's licensing process.

The next step in this process will be the placement of these proposed regulation amendments on the Nevada Legislative Commission agenda, which is anticipated at the Commission's August 2024 hearing, the specific date is still to be determined.
