Applicants for Consideration of Initial Provisional Licensure

National Polytechnic College

Testified: Silvia Espin presented on the three programs the institution will be offering in Nevada. The

main campus is based in Lakewood, CA focusing on health care occupations and accredited by ACCSC along with programmatic accreditation. She provided an overview

of the College's history.

Discussion: Commissioner Mikhail asked about clinical sites and partners for Nevada. Ms. Espin

indicated that they have some national partners with Nevada locations but haven't developed Nevada specific contracts. Commissioner Mikhail asked about funding consideration and Mr. Mugrdechian responded that they anticipate at least a six-month delay in the Title IV approval but will also apply for the VA education program after approval and are considering some private funding options and self-funding for the first six months. Commissioner Mikhail asked about program outcomes and Mr. Mugrdechian responded that the program range between 75 -85% and consistently over the 75% rate. Commissioner Kenny asked if the Career Service Director could provide more precise numbers, and Leslie Kong confirmed the numbers provided by the owner. Commissioner Fredrick recommended the institution reach out the VA Southern Nevada Health as they

have been expanding with a women's clinic and second nursing home.

Motion: Commissioner Frederick– That a twelve-month provisional license be granted to National

Polytechnic College to offer the Associate of Applied Science Program in MRI

Paralegal Institute

Testified: Matthew Phau provided information about the institution and that he has taught this

program at UNLV and originally appeared at the Commission for an added program with another institution. His program is geared to providing the basics needed to enter the

occupation.

Discussion: Commissioner Kerner asked about the types of law covered. Mr. Phau indicated they focus

in the areas where there are the most hires including business contract law, civil litigation, family law and estate planning. Commissioner Mikhail asked about the previous outcomes at NTI and Mr. Phau responded that they never started a class. Commissioner Mikhail asked about the UNLV program being listed under continuing education. Mr. Phau explained that the program was focused on career change versus someone graduating from high school. Many of the individuals attending the program already had a degree but needed the specific skills with only about 5-10% not having any postsecondary education. Commissioner Frederick asked whether he was aware of past students pursuing a juris doctorate degree. Mr. Phau responded that he was aware of three individuals who worked

for his firm decided to pursue a law degree.

Sound Connect

Testified: Alejandro Rodriguez Dawson provided an overview of the two programs the institution

plans on offering. He provided information on his success in the audio engineering industry, having won an Emmy as the audio engineer and founding a recording studio

Junction Sound in Las Vegas.

Discussion: Commissioner Todtman asked about placement assistance for graduates. Mr. Dawson

explained that students will participate in an externship and the program will help students

create a digital resume that will include a playlist of what the person worked on whether they produced it, recorded it or assisted with social media marketing. The studio has already been working with the EmployNV hub in the WEX program. Commission Mikhail asked about recruiting plans. Mr. Dawson explained his plans for campus tours, workshops about the industry and social media marketing, content creation and tutorials. He has also reached out to a new Chamber for arts, creative and entertainment industry to network. Commission Frederick recommended the institution to reach out to high schools with art and music focus. Commissioner Kenny asked if there were other partners to provide externships. Mr. Dawson provided information on a commercial studio and another engineer that works out of his recording studio. He has been working to build this component to provide more opportunities for students.

Motion: Commissioner Todtman – That a 12-month provisional license be granted to Sound

Connect to offer the audio engineering and the pro tools programs contingent upon receipt of surety bond in the amount of \$24,500, personnel, information, facility, and

curriculum approvals.

Vegas Print School

Testified: John Pinnington described his background and how he has built a successful print shop in

Las Vegas and how it is difficult to find employees who have any working knowledge of the commercial print business. He began training employees and developed a curriculum to be able to open the institution. Mr. Pinnington described the four training programs to be offered by the school and the hands-on experience and companies he has identified in need of qualified individuals. He has been active in the EmployNV hub and planning on

working with them to train the workforce.

Discussion: Commissioner Mikhail asked about how the hands-on experience would occur. Mr.

Pinnington indicated that he had a truck that students would be able to practice wrap and a door that would be a first project. The film can be removed to repeat the process. He indicated that he had qualified instructors including himself to provide the training. Commission Mikhail asked about whether graphic design was part of the program and Mr. Pinnington indicated that he has a graphic department and to include this would be a longer training. Commissioner Ponder asked about starting wages for graduates, which Mr. Pinnington responded the range is from \$16-\$20 per hour. We are encouraging at least \$18 hour but \$16 is where most printers start. Commissioner Ponder asked about after a few years on the job and the response was between \$20-\$25 per hour. Commissioner Frederick asked if anyone else is teaching this because it is very forward thinking and cool. It was confirmed that no other training like this is approved. Commissioner Kenny asked about payment for the program. Mr. Pinnington indicated that they were applying for grants as a nonprofit, having other shops pay for employee training and he has spoken with the veterans chambers about possible programs to assist. Commissioner Abe provided information on the WEX program with the Career Enhancement Program which is state

and WIOA funded.

Motion: Commissioner Kenny – That a twelve-month provisional license be granted to Vegas Print

School to offer four programs in Car Wrapping; Commercial Printing; Large Format, and Screen Printing upon receipt of surety bond in the amount \$14,000, and personnel

Order to Refund

Career College of Northern Nevada

Testified: Administrator Wuest explained this is the third list of student indemnification claims

and there are three claims, two new and one revised because the student was able

to provide receipt evidence of the cash payment. The period for claims will close at the end of the week since it is 12 months from the date of closure. I can confirm all the 25 veterans were taken care of through restoration of entitlement. They got back the benefits they used while attending the institution. CCNN is on the closed school list for federal financial aid. Students can contact them and file a claim to have their student loan dismissed. Staff have also been able to provide 16 diplomas to past students. We did take possession of the past diploma's when we secured the campus records so they would not be destroyed. As students reach out to us, we check to see if we have the original diploma.

Starting July 2024, we began collecting the \$5 new student fee to replenish the student indemnification account. So far, we have collected \$89,800 and will pay out students as the funds become available. We anticipate completing payouts by May 2025.

There is a new bill AB 164 that has proposed to increase the student indemnification account from \$250,000 to \$750,000. If it passes it will take approximately 4 years to replenish the account and 2 years if the amount remains the same. I want to remind institutions that they can charge \$5 to students if they wish and recommend it for the short term, low cost programs.

Discussion: None.

Motion: Commissioner Kenny – That we approve the claims as submitted.

Second: Commissioner Frederick.

Results: Commissioner Todtman left prior to vote- all other votes approved; motion carries.

1. Opening and Closure Updates

The following institutions received an initial provision license to operate during the 1st Quarter of 2025

Charter College – 2/5/2025 Vegas Print School – 3/6/2025

Closures

Bodhi Tree Healing Arts- Teach out completed 2/2025. All transcripts received.

New Vista – Notified in 2024 but did not complete closure paperwork no enrollments since prior to Covid.

2. Career College of Northern Nevada closure updated

The claim period for CCNN expired on February 8, 2025. A total of 51 verified claims were received resulting in more than \$525,000 in tuition to be reimbursed from the Student Indemnification Account. The Commission has the last approval request for claims to be considered at this meeting.

3. VA Updates

CPE will host the School Certifying Official (SCO) conference on June 5, 2025. Touro University has agreed to be the host institution and registration is now open.

At the biannual report, CPE/SAA met the performance measures for the agreement and are on track to finishing the year with the highest rating of SAT.

4. Computer System updates- Staff have reviewed many of the system structure and EDvera has bee quickly updating. We still need modification for curriculum, VA applications, payments and reporting for the system to go live.

5. Legislation -

AB 164 – Increases the Student Indemnification Account minimum from \$250,000 to \$750,000 made it out of Committee. Dr. Kirner and Ms. Wuest testified in Las Vegas while Dr. Kenny provided testimony via phone.

AB375 – Concerns delivery of alcohol and expands the reach of the Alcohol Beverage Awareness Card across the state and would require food service delivery drivers to obtain the card. Currently the ABA cards are only required in Clark and Washoe counties.

SB78 – Creates the structure of Boards and Commission department under Business and Industry. CPE was eliminated from the Bill in Section 6 of the amendments. Staff are still closely monitoring this bill as it makes substantial changes to many of the occupational board structures.

Southern States University was originally licensed during the May 4, 2016, meeting. The institution was previously accredited by ACICS which was derecognized by the U.S. Department of Education. The institution is in the process of gaining accreditation with the Higher Learning Commission and meets Nevada requirements to operate as an unaccredited degree granting institution.

At the May 1, 2024, meeting, the Commission motioned to move SSU to a one-year provisional license, capping enrollments to 20 students, reporting any changes with BPPE licensing status and requiring quarterly updates on accreditation process to the Administrator. SSU has provided CPE staff with quarterly updates concerning enrollments, completions, California licensing and accreditation.

I recommend that:

The provisional license for Southern States University be extended for an additional twelve months with the following requirements:

Set an enrollment cap at no greater than 20 students at any given time Require adjustment of surety bond to 100% liability at \$172,000 Require SSU to report student enrollments, drops and completions to CPE on a quarterly

Require SSU to immediately report any changes in BPPE licensing status Require SSU to provide CPE any notices from the Higher Learning Commission upon receipt.

All four programs are approved by Transnational Association of Christian Colleges and Institutions (TRACS).

NC Lab was granted provisional approval to offer the certificate program in Python Developer during the February 1, 2023 Commission meeting. All contingencies were fulfilled, and the license was issued on February 21, 2023. NC was granted an extended

provisional license in February 2024 for no enrollments.

CPE staff met with Mr. LaFrance in September 2024 concerning the institution. NClab has been providing training in conjunction with University of Nevada Reno as part of a degree program and with College of Southern Nevada and Truckee Meadows Community College. While NClab provided the online software and education support, all funds and student enrollment occurred within the public institutions resulting in the zero enrollments reports. CPE staff are working with NClab to have the student enrollments properly recorded.

At the November 6, 2024 Commission meeting, NCLab was granted an 9 month extended provisional license to address student enrollment challenges in the Python Software Developer program. In addition, the Commission approved two new programs: the Data Analyst program (315 hours) and the Automation Technician program (105 hours).

On February 26, 2025, the institution submitted two new added programs for Data Analysis Mini-Credential (175 hours) and SQL Mini-Credential (105 hours) to enable NClab to enroll students in the programs as an institution outside of the contractual agreements with Nevada System of Higher Education. These programs are within the institution's scope of operation but require the Commission to permit the addition through a motion since the institution is in a provisional status.

I recommend that:

NC Lab is granted approval to add the new programs in Data Analysis Mini-Credential and SQL Mini-Credential.

Subject: Student Indemnification Claims

Career College of Northern Nevada Closure

For Action: May 7, 2025

The following are student indemnification claims for students attending the Career

College of Northern Nevada when the school precipitously closed on February 9, 2024. A total of 226 students were impacted by the closure.

Starting in Quarter 3 (July 1, 2024 – September 30, 2024), CPE began collecting the required \$5 per new student fee pursuant to NRS 394.557 to be deposited into the Account for Student Indemnification due to the account falling below the \$250,000 required amount. This is a fee that can be charged to incoming students by the institution and will remain in place until the account balance reaches a minimum of \$250,000. NRS 394.520 requires a \$10,000 reserve to be held in the account at all times. As of April 9, 2025, a total of 44 claims have been paid out (\$474,101.36) and 5 additional claims are in various stages of processing.

The list of 2 students, tuition and fee changes along with the indemnification amount for each student is attached for the Commissions review. The time frame for student indemnification claims closed on February 8, 2025, and no additional claims will be accepted. If approved by the Commission, claims will be processed as funds become available in the account based on the submission date and return of the Claim Release Form. Student Indemnification Fund collection for the quarter January 1, 2025 – March 31, 2025, was reported in the Administrators Report.
